

#### SPORTS AND RECREATION COMMISSION

### CLUB, ACADEMY, AND FACILITY REGISTRATION REQUIREMENTS:

All clubs that participate in sport and recreation activities in Zimbabwe are required to register with the Sports and Recreation Commission of Zimbabwe. The SRC is the regulator of all sport and recreation activities in Zimbabwe constituted in terms of the Sports and Recreation Commission Act (Chapter 25:15). Clubs register through their respective National (Sport or Recreation) Associations (NAs) and in the absence of an NA, registration must be done with the SRC directly<sup>1</sup>. In addition all NAs, Clubs, Local Authorities or other owners of recreational facilities are also required to register such facilities with the SRC<sup>2</sup>.

Below are the registration requirements:

### 1. Club Registration

- a. Application letter addressed to the Director General
- b. Signed copy of Constitution of the club (plus constitution adoption meeting minutes and original meeting attendance register)
- c. Completed Form S.R.C 2 attached (for single-code club where there is no registered NA or for multi-code club)
- d. List of members of the club
- e. Payment of prescribed registration and licence fees

### 2. Academy Accreditation

- a. Application letter addressed to the Director General
- b. Signed copy of Constitution of the academy (plus constitution adoption meeting minutes and original meeting attendance register)
- c. List of members of the academy
- d. Payment of prescribed accreditation and licence fees

### 3. Facility Registration

- a. Application letter for registration of a facility addressed to Director General
- b. Constitutive Documents (e.g. certificate of incorporation, constitution, etc)
- c. Proof of ownership or possession of the facility e.g lease agreement
- d. Completed Form SRC 3 (attached)
- e. Description of facilities (full address, size, activities undertaken thereat)
- f. Payment of prescribed registration and licence fees
