



## **SPORTS AND RECREATION COMMISSION**

### **NATIONAL ASSOCIATION REGISTRATION REQUIREMENTS**

*The SRC is the regulator of all sport and recreation activities in Zimbabwe constituted in terms of the Sports and Recreation Commission Act (Chapter 25:15). This Act requires that all National Associations are registered with the SRC. National Association means any group or body of persons operating in Zimbabwe and having as its principal object the promotion or organization on a national basis of—*

- (a) any particular sport; or*
- (b) any recreational activity;*

*Recreation includes any form of recreational activity which is not a sport.*

#### **Registration Requirements**

1. Application letter addressed to the SRC Director General
2. Constitution,
3. Rules and Regulations,
4. Notice and agenda of the meeting where the constitution and rules and regulations were adopted,
5. Minutes of the meeting adopting the constitution and rules and regulations,
6. Register of attendance (original) for the meeting that adopted the constitution and rules and regulations,
7. Completed Form S.R.C. 11
